City of Walnut Creek Frequently Asked Housing Questions







1. What affordable housing programs are there in the City of Walnut Creek?

There are over 500 affordable homes in the City of Walnut Creek, including both rental and ownership units. In addition, the City offers down payment assistance through the First Time Home Homebuyer Loan Program.

Affordable Rental Opportunities: The City works with developers to create affordable rental units by restricting the rents of these units so they are affordable to lower income households. Please refer to the City's list of affordable rentals or visit City's Affordable Rental Housing webpage for more information or to contact the developments for waiting and application inquiries. Please note, the City does not accept, process, or handle any applications and waiting lists.

Below Market Rate Home Ownership Opportunities: Developments located throughout the City of Walnut Creek feature below market rate (BMR) homes. Ownership BMR homes are offered at restricted sales prices to households with low to moderate incomes. Available BMRs for sale and additional information are posted on the Below Market Rate Homeownership Program webpage.

First Time Homebuyer Loan Program: The City's First Time Homebuyer Program was established in 1994. The program assists low and moderate income households with the purchase of housing within the City by giving the household a loan to assist with a portion of the down payment. Interest-free equity share loans are available to qualifying homebuyers. For more information, please see the brochure or visit the City's First-Time Homebuyer Assistance Program webpage.

Rehabilitation Loan & Emergency Grant Program: The City contracts with Habitat for Humanity to provide low-interest rehabilitation loans and emergency grants to lower income Walnut Creek home-owners for the purpose of improving their Walnut Creek Home. Four developments in the City of Walnut Creek offer affordable housing specifically for seniors:



Villa Vasconcellos is a 69-unit affordable housing apartment community located on 1515 Geary Road. It offers one-bedroom apartments for households with at least one member age 55 or older. Please contact the leasing office at (925) 465-5462.

The Housing Element addresses the existing and projected housing needs for all economic segments of the community, and is the only component of the General Plan that is subject to State review and certification. The City's Housing Element was last updated in 2014 for the 2015 to 2023 planning period.
