AN INTERIM ORDINANCE ADOPTING AN OVERLAY ZONE RESTRICTING THE ESTABLISH-MENT OF FUTURE USES ON THE SAN MIGUEL ELEMENTARY SCHOOL SITE

WHEREAS Government Code ection 65858 of the State of California provides that the City Council, in order to protect the public health, safety and welfare. may adopt as an urgency meas-ure an interim ordinance prohibiting any uses which may be in conflict with contemplated zon-ing proposals; and

WHEREAS the Mt. Diablo School District has closed, for educational purpose, the San Miguel Elementary School locat-ed in the City of Walnut Creek:

WHEREAS the existing School site is in the process of being disposed by the Mt. Diablo School District as surplus property; and

WHEREAS the existing Walnut Creek General Plan designates this site's playfield as an integral part of the City's existing park facilities; and

WHEREAS the existing R-8 Single Family Residential zoning does not specifically address the need for preservation of the playfield or set forth standards which future land use activities must meet for the remainder of the property; and

WHEREAS the City's Overlay Zone category can be used to es-tablish controls in excess of the allowances of the underlying zone so as to ensure both preservation of specific features of given sites and the character of the area in proximity to the subject

site; and WHEREAS the City is undertaking a zoning study to evaluate the appropriateness of the existing zoning as it relates to the above concerns and any other concerns that might arise during the public hearing process re-quired by State Planning law.

NOW THEREFORE, the City Council of the City of Walnut Creek does ordain as follows: Section 1. The real property

shown on the map marked Exhib-it A, attached hereto and made a part hereof, is hereby rezoned by adding an Overlay Zone to the R-8 (Single Family Residential) zoning applicable to the San Miguel site, subject to all provisions of the following conditions, and the Municipal Code is hereby amended accordingly:

 The area designated a "Playfield" on Exhibit A shall remain undeveloped and be availa ble for public recreation use. This does not mean that such playfield need be publicly accessible at all times, but rather for at least reasonable periods (such as on weekends and early eve-

nings).

2. Future uses on the area designated as "Future Development" on Exhibit A shall:

A. Not generate traffic in excess of the average trips per day attributed to the site when it functioned as a public school in

B. Not require more on-site parking than is presently provided.

C. Not require additional

building square footage. Section 2. This ordinance is hereby declared to be adopted pursuant to Section 65858 of the Government Code of the State of California and is necessary for and is required to protect the public safety, health, and welfare of the citizens of Walnut Creek for the reasons stated above.

Section 3. The City Council hereby directs the Community Development Department and Planning Commission to consid-er the appropriate text amendments and permanent zoning for the property described in said Exhibit A, and to render their re-port to the Council. Section 4. This ordinance

shall take effect and be in force immediately upon its passage and adoption and shall be of no further force and effect four (4), months from the date of the adoption thereof unless extend-ed as provided by law.

Section 5. If any section, subsection, subdivision, paragraph, sentence, clause or phrase of this ordinance or any part thereof is for any reason held to be invalid, such decision shall not affect the validity of the remain-ing portions of this ordinance or y part thereof. The City Council hereby declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase there-of, irrespective of the fact that any one or more sections, sub-sections, subdivisions, para-graphs, sentences, clauses or

phrases be declared invalid.
