AN ORDINANCE I ROVIDING FOR THE REZONING OF CERTAIN PROPERTY WITHIN THE CITY OF WALNUT CREEK BY ADDING AN OVERLAY ZONE TO THE PROPERTY PRESENTLY ZONED R-O (RETAIL AND OFFICE) LOCATED AT 2099 MT. DIABLO BOULEVARD, AND AMENDING THE WALNUT CREEK MUNICIPAL CODE ACCORDINGLY (OVERLAY ZONE II) (REZONING APPLICATION NO. 8371 - BEKINS VAN AND STORAGE)

The City Council of the City of Walnut Creek does ordain as follows:

Section 1. The real property described in Exhibit A attached hereto and made a part hereot, is hereby rezoned by adding an Overlay Zone to the property presently zoned R-O located at 2099 Mt. Diablo Boulevard, subject to all provisions of the Walnut Creek Municipal Code and subject to all the following conditions, and the Municipal Code is hereby amended accordingly:

 The subject property shall be subject to all provisions of the R-O, Retail and Office, Zone except that if the use of the existing building is limited to retail sales which primarily consist of furniture or appliances the following regulations shall apply:

a. There shall be not less than one parking space per 400 square feet of gross floor area including all stories and the mezzanine.

b. Other retail sales may be approved by the Planning Commission with the same parking requirements as described above upon the finding that the business is similar to retail sales of furniture or appliances and has a similar parking demand.

c. In the event the existing building should be destroyed as described in Section 10-2:2009 of the Walnut Creek Municipal Code, the building shall not be rebuilt unless the new construction conforms to all provisions of the R-O Zone.

 Prior the occupancy of the building by any retail use, the site shall be made to conform to all requirements of the Municipal Code, except as provided above, including design review, landscaping and parking design.
