## ORDINANCE NO. 1525

AN ORDINANCE PROVIDING FOR THE REZONING OF CER-TAIN PROPERTY WITHIN THE CITY OF WALNUT CREEK FROM LAND USE DISTRICT P-D-971 (PLANNED DEVELOPMENT) TO LAND USE DISTRICT R-10 (SINGLE FAMILY RESIDENTIAL) AND ADDING AN OVERLAY
ZONE 14 TO THE AFFECTED
PROPERTY AND AMENDING
THE WALNUT CREEK MUNICI-PAL CODE ACCORDINGLY (REZONING PROPOSAL NO. 7068-20, CHAPABRAL)

The City Council of the City of Walnut Creek does ordain as follows:

Section 1. The real property described in Exhibit A, attached hereto and made a part hereof, is hereby rezoned from land use district P-D-971 (Planned De-velopment) to land-use district R-10 (Gingle Family Residential) subject to all the provisions of the Walnut Creek Municipal Code and the Walnut Creek Municipal Code is hereby

amended accordingly.

Section 2. In addition, the real property as described in Exhibit A is hereby further rezoned by adding Overlay Zone No. 14, and is subject to all the provisions of the Walkutt Creek. provisions of the Walnut Creek Municipal Code and subject to the following conditions:

 All lots shall provide side yards of ten feet on both sides except that one side yard may be reduced to five feet on those lots which do not conform to the R-10 lot width requirements as defined in Section 10-2:101(ay) of the Walnut Creek Municipal Code, specifically Lots 25, 26, 40, 43, 52, 53, 54, 55 and 56 of Subdivision No. 3973.

2. All common areas shall be maintained pursuant to Article VIII of the document entitled "Amended Declaration of Covenants, Conditions and Restrictions: Chaparrat Homeowners Association, Inc." recorded May 11, 1973 in Book 6941 of Offi-cial Records of Contra Costa

County, at Page 635.
Section 3. The Community
Development Director is hereby directed to amend the zoning map of the Walnut Creek Municipal Code accordingly.

Section 4. This ordinance shall become effective thirty (30) days after the date of its final passage and adoption. PASSED AND ADOPTED by
